Scouting Settlement Trust Quarterly Claims Report – FY23 Q2

The Trustee's work on behalf of the survivors of sexual abuse began on April 19, 2023, when the plan went effective. The Trustee's first priority was to design and establish the procedures necessary to open and allow the 82,000 Survivors to submit claims in a timely manner. That step required large-scale planning, development, and implementation of the many components required for an efficient settlement program.

As of June 30, 2023, the Trust was not yet accepting questionnaire submissions. The tables below are illustrative of the statistics the Trust plans to provide, once available.
