
Several items of note occurred during the quarter:

- On August 4, the Trust launched the Claims Processing Portal and began accepting Claim Questionnaires for the first group of Claimants including approximately 7,000 Claimants who selected the Expedited Distribution (or "quick pay") process.
- On August 17, the Trust opened the Claims Processing Portal to the remaining approximately 75,000 Claimants who are selecting either the Matrix claims process or the Independent Review Option ("IRO") process.
- On September 19, the Trust began making disbursements on allowed claims.




