





*Expedited Distribution claims were sent an initial disbursement of \$2,535. A holdback of \$965 was applied to address potential healthcare liens. Supplemental payments are made once healthcare liens are resolved.

**This includes 647 APP Payments, totaling to \$647,000. For non-APP Matrix distributions the initial distribution amount was 1.5% of the allowed claim amount.
