 The Trust Claims Questionnaire will ask for information about your experience and will provide an opportunity for you to share additional details and documentation you believe we should consider when evaluating your claim. 	
 Once your signed Trust Claims Questionnaire has been submitted to the Trust, it will be reviewed in the order received by specially trained Independent evaluators who are retained by the Trust and subject to strict confidentiality and non-disclosure rules. 	
 Generally speaking. If your claim is allowed, you or your counsel will receive a formal offer of compensation from the Trust in accordance with the Claims Matrix approved by the Bankruptcy Court the plan of reorganization and detailed in the Trust Distribution Procedures for Abuse Claims.
